

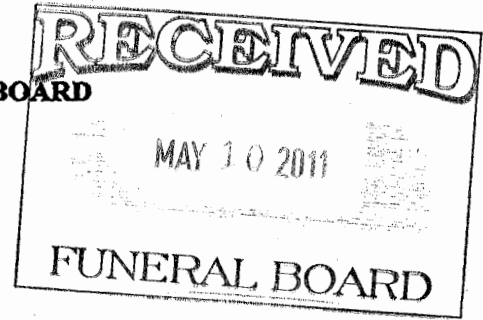

**CONSENT ORDER RESOLVING APPEAL**

This matter came on for approval this 11 day of May, 2011, of the Settlement Agreement entered into between the parties at the Settlement Conference before Judge Milton Craig in regard to the Oklahoma Supreme Court Case styled Jimmy Dale Spurlock, Appellees, et al. vs. State of Oklahoma ex rel. Oklahoma Funeral Board, Appellant, Case No. DF-109059, being on Appeal by the Oklahoma Funeral Board from the District Court of Okmulgee County, Oklahoma, Case No. CV-2010-22, and the Board being fully advised FINDS and ORDERS:

1. The Settlement Conference Agreement of April 26, 2011 is hereby approved and as contained within this Consent Order.
2. The Oklahoma Funeral Board's appeal in the above described Oklahoma Supreme Court Case from the District Court of Okmulgee County is dismissed.
3. The funeral director and embalmer licenses for Robert Owens, Jr. are **SUSPENDED** for thirty (30) days and Respondent Owens must successfully pass


the Oklahoma Funeral Board law examination prior to reinstatement at no cost to him.


4. The day after the completion of the suspension of Respondent Owens's funeral director and embalmer licenses, the funeral director and embalmer licenses for Jimmy Dale Spurlock are SUSPENDED FOR thirty-six (36) months and Respondent Spurlock must successfully pass the Oklahoma Funeral Board law examination prior to reinstatements at a cost of \$100.00.
5. The funeral establishment, Integrity Funeral Service, LLC, is assessed an administrative penalty of Seven Thousand Five Hundred dollars (\$7,500.00).
6. Billboard and other advertising that are capable of being changed to eliminate Respondent Spurlock's name as licensee are to be corrected by the date of the beginning of Respondent Spurlock's suspension. Long term book directory, phone, etc. type advertising is to be so changed to eliminate Respondent Spurlock's name as a licensee at the next annual contract period.
7. This order shall be effective 10 days after receipt by the Respondents.
8. Each party is to pay their own attorney fees and costs.


